Joel Vander Molen, Olmstead Consumer Task Force vice chair called the meeting to order at 10:01am thanking the Task Force and the public for their attendance. Quorum was established.

State Agency Updates

Kim Walford, Department of the Blind, read by staff support, Falicia Beck, The Rehabilitation Services Administration (RSA) has completed the reallotment process for Federal fiscal year (FFY) 2024 for the Independent Living Services for Older Individuals Who are Blind (OIB) program. Iowa's award was \$12,434.00 of the total one-time funds available. Federal Fiscal Year (FFY) 2025 beginning October 1, 2024, program services at the department will continue for eligible Iowans who are 55 years and younger with Iow vison or who are blind and have secondary or tertiary disability. The agency will no longer be receiving Chapter VII, Chapter 1, Part B funding through the now ratified 2024-2027 Iowa State Plan for Independent Living (SPIL) as executed by the Statewide Independent Living Council (SILC) and Centers for Independent Living (CILs). The SPIL outlines how the Part B funding will be used instead.

Megan Marsh, Iowa Finance Authority, provided an update about the Home and Community-Based Services (HCBS) Rent Subsidy Program, they are continuing to serve individuals and the current waitlist is approximately two to four months.

Paula Connolly recommended the Taskforce share this document to legislators, businesses, and organizations throughout lowa.

The Medicaid & Legislative Watch Committee updates were provided by Paula Connolly, the chair of the committee. Since this is Paula's last meeting as a member, there is a Taskforce

member who is looking to chair the Medicaid & Legislative Watch Committee. At the next committee meeting members will have a discussion about the legislative priorities, and prospective dates for an OCTF Legislative Event. There was also a call for members to be willing to share their stories at these events.

Recognition of Paula Connolly – Outgoing OCTF member

Paula Connolly was recognized for her time as a member serving both her full two terms and fulfilling a past member's term. Paula served as the chair of the Medicaid Committee which became the Medicaid & Legislative Watch Committee in 2023.
